Booking Terms @ Conditions

Important

General Information

Check-In / Checkout

- The check-in / checkout time is 12 noon. If arriving late night / early morning, the room has to be booked from the previous night for immediate occupancy.
- A half day charge may be levied if check-in between 0800 - 1200 hrs.
